

## **Information note of Reddeergames sp.z o.o. about personal data of participants in competitions and similar initiatives**

### **Who do I entrust my personal data to? How to contact him?**

REDDEERGAMES sp. Z o. O. with headquarters in Szczecin, ul. Zbożowa 4a lok. 2, 70-653 Szczecin, Poland, is the organizer of various competitions and initiatives. If you take part in them, this company is responsible for the processing of your personal data. It is the administrator of your personal data - it determines the purpose and method of processing your data. Personal data means information about an identified or identifiable natural person. For example, it may be: the user's e-mail address, first and last name or other data that the user provides to the administrator, e.g. via web forms, e-mail, etc.

The personal data entrusted to us is safe. We undertake to use them in accordance with the provisions of Polish law and in accordance with the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation) ("GDPR").

### **What can you expect from the information note on data protection?**

This document presents the purposes and methods of processing the personal data of users participating in competitions or initiatives of Reddeergames sp. Z o.o .. You will learn from it how we will use the personal data you have entrusted to us. The document will also tell you what your rights are regarding the processing of personal data and how to contact us.

### **What data is collected and what data is not collected?**

It is customary to collect basic data that allows us to contact participants of our competitions and initiatives. These are: name and surname, email address, telephone number, home address. Sometimes we may collect additional data and it will depend on the nature of the relationship with a given user, e.g. we will require the winner to provide their bank account number to pay the prize money. However, it will always be data that the user voluntarily provides to us.

We collect only the data necessary to conduct competitions and initiatives, we do not collect other personal data, unless otherwise explicitly stated in the participant of a given initiative or competition. If we ask you to subscribe to our newsletter, it means that we will use your e-mail address to notify you about our various news, projects and issues.

Under no circumstances will we collect and process sensitive personal data: revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership and genetic data, biometric data in order to uniquely identify a natural person or data regarding health, sexuality or sexual orientation of that person.

## **What is the legal basis for data processing and how long will the data be processed?**

The legal basis for the processing of your personal data is usually the need to implement a competition / initiative in which you want to participate (pursuant to Article 6 (1) b of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons. in connection with the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (General Data Protection Regulation) - GDPR. We send our newsletters based on your consent to receive e-mails and our legitimate interest (Article 6 (1) (f) of the GDPR), which is the right to implement direct marketing, i.e. to communicate with our subscribers in order to present new information, products, services, etc.

Please be advised that providing us with personal data is not a statutory requirement and that you are not obliged to provide it. If you want to take part in a competition or other initiative organized by us, the provision of data is necessary to ensure your participation in a competition or other form of activity.

As a rule, we will process your data for the duration of the competition or initiative in which you participate. Nevertheless, we may store your data longer if this processing is justified by law (e.g. for accounting and tax purposes) or if we anticipate that the archiving of your data is necessary to protect our rights. In this case, we will process data for the period required by law or the limitation periods for claims resulting from legal provisions.

If you have subscribed to our newsletter, we will send it to you as long as you do not unsubscribe. You can unsubscribe from the newsletter by sending us an e-mail with a relevant request to [play@reddeergames.com](mailto:play@reddeergames.com) or by clicking the appropriate button in the e-mail.

## **Methods and purposes of data processing**

We collect personal data provided by users in the manner specified above, by electronic means, and their processing is carried out electronically or manually. We also use automatic sending of electronic correspondence.

We use the information you provide for the following purposes:

- those inherent in participation in our competitions or initiatives (we collect and use data in particular to contact people who participate in them, including for the purpose of awarding prizes)
- in order to send the newsletter to the e-mail address provided by the user, if the user has agreed to receive the newsletter.

## **How do I change or delete information about me? What are my rights?**

In matters related to your data, you can contact us by sending an email to [play@reddeergames.com](mailto:play@reddeergames.com). This address is used so that you can contact us regarding your data and that you can exercise your rights related to the data provided to us.

You have the right to request access to your personal data from us (we will inform you about your data), rectify it (if you want to correct your data), delete or limit processing (you can select the data we will process or request that we delete all your data) or the right to object or the right to transfer

your data to another entity. We assure you that we secure our IT systems to protect your data. You have the right to obtain a copy of the data you provided to us.

Please be advised that in connection with entrusting us with our data, you have the right to lodge a complaint with the supervisory body, which is the President of the Office for Personal Data Protection in Poland.

**Who are the recipients of personal data?**

Your personal data may be transferred to third parties - our subcontractors, only when we use the services of subcontractors, especially those who manage our databases on our behalf and for us.

We may transfer your personal data to our various subcontractors: accountants, lawyers, IT subcontractors, subcontractors supporting us in the implementation of competitions and initiatives, subcontractors sending us automatic correspondence, etc. We do not go beyond the purposes of data processing referred to in this information note.

**Does the so-called "Profiling" occur?**

We indicate that we do not profile the personal data of participants in our competitions and initiatives. This means that we do not carry out automated analyzes that allow us to evaluate various factors of natural persons.
